# **SIL Employer Cash Fund**

This fund update was first made publicly available on: 28 September 2022

#### What is the purpose of this update?

This document tells you how the SIL Employer Cash Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Superannuation Investments Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The SIL Employer Cash Fund invests mainly in cash and cash equivalents. Investments may include cash and cash equivalents issued by New Zealand registered banks, the New Zealand Government, corporations or local authorities, or non-New Zealand governments.

The fund aims to achieve a return (after the fund charge and before tax) on average over rolling three year periods that is in line with the relevant market index.

#### What are the risks of investing?

Risk indicator for the SIL Employer Cash Fund:



## Annual return graph

Small differences in fees and charges can have a big impact on your investment over the long term.


#### Example of how this applies to an investor


Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$36 (that is 0.36% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$36 for the year.
